<b>Optional Redemption:</b>	At any time on or after January 21, 2019, the Issuer may redeem, in whole or from time to time in part, the Series C Preferred Stock at a redemption price of \$25.00 per share plus an amount equal to all accumulated and unpaid dividends thereon to the date of redemption, whether or not declared.

If the application is approved, trading of the Series C Preferred Stock on the NYSE is expected to begin within 30 days after the original issue date of the Series C Preferred Stock. The underwriters have advised us that they intend to make a market in the Series C Preferred Stock prior to commencement of any trading on the NYSE. However, the underwriters will have no obligation to do so, and no assurance can be given that a market for the Series C Preferred Stock will develop prior to commencement of trading on the NYSE or, if developed, that it will be maintained.
